By design, the PGC's annual tuition has a deficit of about \$800 per singer so that all girls may participate in our program regardless of family economics. Through foundation and corporate support, the PGC has traditionally been able to cover half that amount. As a community, the PGC families make up the remainder, through our fund-raisers, and through our Annual Contribution Campaign. Foundations look closely at the percentage of families who participate when deciding whom to fund for future grants-the PGC's goal is 100% participation from all families, regardless of amount.
